OFFICIAL STATEMENT COVID-19 CRISIS: AMENDMENT TO NEW DATES FOR PHYSICAL ADMISSION TO CAMPUS FOR SEMESTER II, ACADEMIC SESSION 2020/2021

8 February 2021

1. Universiti Malaysia Pahang (UMP) had issued an official statement regarding the Students Physical Admission to Campus for Semester II, 2020/2021 on 2 February 2021 and the government's announcement on the extension of the Movement Control Order (MCO) for all states except Sarawak until 18 February 2021. The university has agreed to amend the dates for the

physical re-entry of students as follows:
